# GEORGE'S MINNESOTA MUSKIE EXPO

## RULES AND REGULATIONS - EXHIBITORS INFORMATION

### Payment Terms

Exhibitor will pay \$200.00 of the booth fee with the signed Agreement by November 1, 2018, and the remaining amount will be paid by January 1, 2019. In order for discount savings to apply, remaining amount must be received by December 1, 2018.

### Booth Equipment

Shall consist of standard 10 foot by 10 foot booths erected by the Expo Management at no cost to the exhibitor in space provided.

### Display Regulations

- a. Non-bulk space booth displays are limited in height to 8 feet (including signs) and cannot extend more than four feet from the booth background. Sidewall displays are limited to 3 feet in height. Exhibitor's display should not obstruct neighboring displays or project into the aisles.
- b. Booths located along a perimeter wall, however, may exceed the backwall height limitations to a maximum of 12 feet in height.
- c. No decorations or product shall be hung from the ceiling. All signs to be hung from the ceiling must have prior approval of Expo Management.
- d. These guidelines will be strictly enforced. Expo Management reserves the right to remove any display that does not conform to these guidelines or any display that Expo Management deems offensive or detrimental to the show for any reason.

### Fireproofing

All decorative material shall be fireproofed. Smoking is prohibited by Minnesota State Law in the entire facility.

### Show Hours

All booths must be properly manned during show hours.

Select MN Muskie Expo. Once contract is returned, you will be mailed the password to order your furnishings.

Expo secures the building after-hours, but George's Minnesota Muskie Expo and Concordia University will not be responsible for any loss or damage suffered by the exhibitor or its employees or guests from any act of theft, vandalism or accidental injury.

### Liability
